Councillor Alexander advised of an invitation received on behalf of the Corunna Community Policing Committee for her to be the Neighbourhood Watch Coordinator. In the future, Councillor Alexander will attend meetings of the Corunna Community Policing Committee as the co-ordinator and not a Council representative. Also, Councillor Alexander requested staff to investigate with the Township's general insurance underwriter the possibility of extending the Township's insurance policy to the Moore Centre Women's Institute Hall.
