COORDINATOR OF ENGINEERING SERVICES:

Council discussed the repair options in detail including possible required evidence of Township ownership of the property and the Townships authority to provide any widening from the existing prescriptive road allowance. It was pointed out that Option 1 did not require property acquisition or widening.

DIRECTOR OF EMERGENCY SERVICES/FIRE CHIEF REPORT:

Council reviewed the report prepared by Chief Dewhirst on the tender results for the purchase of self contained breathing apparatus, and further, a pick-up truck to be added to the Fire Services fleet to accommodate the use of a vehicle as a delivery system for replacement air bottles from the Courtright Station to fire scenes. The qualified tenders for the self contained breathing apparatus were as follows:

Councillor Randell advised of receiving an invitation to attend a Prosperity and Sustainability Workshop on May 9th and 10th. It was determined that no other member of Council has been invited to this workshop and if attended by Mr. Randell he will be unable to attend the May meeting of the Committee of the Whole.

Councillor Alexander requested that staff draft a possible summer meeting schedule for discussion by Council at its next meeting.

Councillor Gilliland questioned if the Mayor or Deputy Mayor or any member of Council have been invited to participate in the April 20th Chili Luncheon at the Corunna Legion. No member of Council has been invited. Councillor Gilliland also questioned the status of the request to Lambton County to establish a No Parking Area adjacent to the Corunna United Church handicapped parking. Mayor Dedecker advised that this item was scheduled to be on the agenda for the April 19th meeting of the County Infrastructure Committee.

Also, Councillor Gilliland advised of receiving numerous complaints regarding noise at a Corunna business establishment on Lyndoch Street. Council suggested that complaints received for such occurrences should be filed in writing. It was suggested that the site plan of the subject property be investigated to see if any sound litigation measures that may have been required were omitted.

Councillor Miller advised of receiving questions from area ratepayers regarding disposal of wood from damaged trees relative to the quarantine imposed due to the Emerald Ash Bore in the western section of St. Clair Township. It was suggest that such requests be referred to the Canadian Food Inspection Agency.

It was suggested that prizes to the winning entrance be provided.
