#### **ADJOURNMENT:**

Mayor Arnold called the meeting to order at 5:00 p.m. and asked members of Council to declare any possible conflicts of interest at the appropriate time.

### **DECLARATION OF CONFLICT OF INTEREST:**

None declared.

On behalf of Council Mayor Arnold welcomed Mr. Frank Gare, Chairperson of the Lambton Group Police Services Board and Rosanne Orcutt, a member of the Board to discuss with Council the Board's opinion as to space requirements for the OPP Office in St. Clair Township. It was pointed out that the responsibility for providing space for an OPP presence in St. Clair Township has been delegated to the Police Services Board. Mr. Gare pointed out that the OPP have indicated that their space requirement would be between 6 to 7,000 sq. ft. However, Mr. Gare feels that the Board is prepared to pay for rental accommodations for the Police Station with a size of approximately 4 to 5,000 sq. ft. Mr. Gare further pointed out that in his opinion the Board would be willing to finance rental accommodations for the station from its current budget projected revenues in an amount similar to what it is currently paying for rental accommodations in the amount of \$9.00 per sq. ft. with janitorial costs and utilities above and beyond the basic rental.

Council shared with the members of the Police Services Board its interest in purchasing an unoccupied property in Corunna and using a portion of the space available for the OPP office. At the conclusion of the discussion Mayor Arnold thanked Mr. Gare and Ms. Orcutt for their attendance and information provided to assist Council in its decision making process.

Mayor Arnold turned the next portion of the meeting over to Councillor Carswell Alexander as Chairperson of the Finance and Administration Committee in consideration of the current draft of the 2007 operating budget. As a term of reference Council was considering the joint report filed by the CAO and the Director of Finance dated February 27, 2007 suggesting several budget amendments. Councillor Miller objected to the staff recommendation that capital project 2007-107 be deferred. Council was generally of the opinion that the capital budget as established in December would remain in tact.

## **BUSINESS ARISING OUT OF MINUTES:**

It was pointed out that the meeting originally scheduled for March 13<sup>th</sup> by Lambton County to consider the draft plan of subdivision application for the property known as the former Colborne St. School property has been changed to March 6<sup>th</sup> commencing at 9:45 a.m. Council expressed their concerns on the condition of the remnant property particularly the former Colborne Street School building itself. Deputy Mayor Gilliland questioned the status of the discussion on the proposal to convert the Moore Township Foundation to the St. Clair Township Foundation. It was pointed out that the matter has been tabled with the Mayor to provide further information.

## **DEPUTATIONS AND APPOINTMENTS:**

At the appointed time Mayor Arnold welcomed on behalf of Council, Debbie Coke and Tim Fugard and Chad Anderson representing the Lambton Federation of Agriculture present to discuss with Council several LFA initiatives aimed at assisting the Agricultural community. Mr. Fugard provided Council with stats of the agricultural area comparing the number of farmsteads, acres under production and crop productivity comparing St. Clair Township to Lambton County as a whole.

Ms. Coke thanked the municipality for supporting the 2006 project identifying the location of farm gate retailers. Ms. Coke also detailed to Council the initiative known as Farmers Feed Cities and the risk management program which is a proposed insurance policy for farmers, co-financed by participants and senior levels of government to assist farmers in times of net farm income losses due to crop yield or commodity prices.

Mr. Anderson detailed to Council the LFA's initiatives regarding farming and the environment particularly issues such as nutrient management and conservation tilling. The group offered to Council a sample resolution seeking municipal support for the risk management program.

AND WHEREAS the "whole-farm" policy is penalizing farm operations for good planning and management to mitigate farm loss(s);

AND WHEREAS the Canadian Agricultural Income Stabilization (CAIS) program does not work. A view shared not just by farmers, but both the federal and provincial levels of government;

THEREFORE BE IT RESOLVED that the municipal government level of Ontario support the Risk management Program, an insurance-based solution that will include participation from farmers and the federal and provincial government as put forward by the Farmers Feed Cities campaign as a provincial companion program through the next generation of Canada's Agriculture Policy Framework and that this resolution and request for support be forwarded to the local M.P., MPP's, C.F.A. and the Minister of Agriculture and Food.

Several Members of Council felt that part of the problem with the "local delivery only traffic" on the Parkway was a shortage of appropriate signage.

## **Darrell Randell**

Councillor Randell advised of his recent attendance at the OGRA/ROMA Conference in Toronto, that he found very informative and productive. Councillor Randell also shared with the meeting information he received through the Ontario Ministry of Agriculture and Food on the Rural Economic Development Grant Program. Also, Councillor Randell presented to Council a list of possible tree plantings in compensation for trees removed for the Invenergy Project. It was suggested that the list be forwarded to the appropriate County staff for possible location of tree planting areas.

## Pat Brown

Councillor Brown advised that he also attended the recent OGRA/ROMA Conference at which time he had an opportunity to discuss with the Deputy Minister of Transportation the needs for Highway 40 improvement. Also, Councillor Brown e-mailed staff regarding an open catchbasin that could be dangerous to pedestrian traffic on Lyndoch Street near the intersection of Hill Street.

### **Steve Arnold**

Mayor Arnold advised of receiving a complaint from Mr. Ray Vandenberg, a resident at the intersection of the St. Clair Parkway and the Rokeby Line, regarding what is in his opinion excessive truck traffic in the area. The Mayor questioned the status of an earlier instruction to staff to install larger advance warning signs for the intersection of Rokeby Line.

Also, the Mayor had a discussion with MPP Caroline DiCocco on recent Bluewater Health issues as reported in the local media. The MPP also advised the Mayor that she is in full support of the current Township application for Ontario Infrastructure Grant Funding for the proposed St. Clair Parkway sanitary sewer extension. Mayor Arnold briefed Council on the attendance at the OGRA/ROMA Conference the audience with Federal Health Minister Tony Clement and the Township's lobbying efforts for senior government funding for various sanitary sewer projects. The Mayor also suggested that Mr. Charles Fisher, Lambton County's Revenue Development Officer be invited to attend the March 14<sup>th</sup> Committee meeting to brief the Committee on efforts made and the status of grant applications that may have benefited St. Clair Township.
