Council was advised verbally by the Clerk of a proposal to conduct a Town Hall style meeting to discuss with the West Lambton Community Health Centre Executives and a Needs Consultant hired by the Health Centre to explore the needs and feasibility of establishing a Health Centre in St. Clair Township. Council was advised that the meeting is proposed to be held Wednesday, April 25, 2007 at the Courtright Community Hall.

DEPUTATIONS AND APPOINTMENTS:

At the appointed time the Mayor welcomed residents of the St. Clair Parkway south of the Courtright Line to discuss the proposal to construct a sanitary sewer extension in that area. The Mayor advised that as detailed at the meeting last fall the project has been re-tendered with a gravity flow system and the tender results were less expensive than those from 2006. The Mayor also pointed out that the Township was successful in obtaining an Ontario rural infrastructure grant for the project totaling approximately \$670,000.00.

The Mayor then turned the meeting over to Mr. Ron Kerr, Director of Public Works who explained the proposal and responded to several questions. Mr. Kerr explained that the final revised schedules of assessment have not been prepared to reflect the lowered net ratepayer costs, but those numbers would be available by contacting the Engineering Department. Mr. Kerr explained that the total estimated cost of the project including engineering and contingencies were approximately 1.1 million dollars and that the Township is not contemplating at this time replacing the watermain in the area. Mr. Kerr and Council responded to various questions regarding assessment on a foot frontage basis the \$1,000.00 connection fee and the possible need for improved road drainage. Several ratepayers questioned the status of the \$150,000.00 committed by the Township to the Mayor Arnold advised that the \$150,000. was a contribution from the project. municipality in lieu of grant funding, and with the successful application of the rural infrastructure grant in the amount of approximately \$670,000.00 the Township contribution of \$150,000.00 would not be forthcoming.

The ratepayers present were supportive in the continuation of the project. At the conclusion of the discussion Mayor Arnold thanked the ratepayers for their attendance.

Councillor Carswell-Alexander also advised of receiving complaints which seems to be deterioration of crack sealant on the St. Clair Parkway. Mayor Arnold advised of his recent visits to area schools and comments received from students regarding various issues including condition of the beaches at the Township owned former St. Clair Parks facilities. Council asked the Director of Community Services to prepare a report for Committee or Council consideration on the condition of the beach facilities. The Director was also requested to contact the Lambton Community Health Services regarding permanent posting for No Swimming at these beaches. Mayor Arnold also attended both Shell public open houses and sensed from the comments received that the proposal enjoys considerable community support. Also, attended with the Treasurer a meeting hosted by Lambton County to discuss property tax capping issues.

NEW BUSINESS:

In response to the Clerk's question, Council advised that in view of the May 21st Victoria Day holiday, the regularly scheduled meeting of Council would be postponed and be held Tuesday, May 22, 2007.

The Clerk also led Council in a discussion of property standards issues and the protocol to be followed in an effort to speed up the process. The Clerk cited several examples where involvement of the Property Standards Officer for relatively minor issues could be delayed for several weeks pending Council approval.
