AND WHEREAS the timetable for the completion of the development of the site will be significantly constrained by the time required to amend the relevant planning document (zoning by-law No. 17 of 2003) through normal procedures;

AND WHEREAS it is the opinion of the Township of St. Clair that the timely approval of the development is in the best interest of the Township, the Province and the proponent;

NOW THEREFORE it is resolved that the Corporation of the Township of St. Clair respectfully requests that the Minister of Municipal Affairs and Housing exercise the Minister's authority under Section 47 of the Planning Act to place the subject lands (see Map 1a), Lands within the Geographic Township of Moore Lots 25 to 29 of Concession 4, Lots 25 to 29 of Concession 3, Lots 25 to 28 of Concession 2, Lots 25 to 28 of Concession 1, Lots 1 to 12 of the Front Concession, and Lands within the Geographic Township of Sombra Lots 1 to 9 of Concession 15, Lots 1 to 5 of Concession 14, and Lots 1 to 5 of Concession 13, now in the Township of St. Clair, in the County of Lambton, under a Minister's Zoning Order to permit a large scale refinery (type 3 industrial use), associated uses, appropriate regulations and to address environmental protection;

AND it is resolved that the Corporation of the Township of St. Clair respectfully request support from the County of Lambton regarding the Ministers Zoning Order;

AND it is resolved that the Township's solicitor be directed to work with the Ministry of Municipal Affairs to finalize the boundaries of the Minister's Zoning Order, provide the Ministry with such information and advise as may be required and report to Council as may be required.

DEPUTATIONS AND APPOINTMENTS:

At the appointed time Mayor Arnold welcomed on behalf of Council Mr. Fred Janess a resident on the Courtright Line in Brigden present to discuss with Council his earlier letter requesting a parking prohibition on the south side of the Courtright Line adjacent to his property. Mr. Janess stated that heavy truck parking in Brigden on road allowance property adjacent to the restaurant is causing vision problems for vehicles, and Mr. Janess further provided Council with photographs showing the dead grass in the area resulting perhaps from leaking loads from the trucks parked there. Mr. Janess further stated that he does not want trucks parked in front of or adjacent to his property, and further asked Council to consider a parking prohibition on the south side of the Courtright Line west of the Brigden Road intersection.

Mayor Arnold advised Mr. Janess that the road in question is under County jurisdiction and that his concerns are already known to Lambton County senior staff, but that the issue would be further discussed at the County Committee level.

REPORTS OF COMMITTEES AND OFFICERS:

Council reviewed applications to the Committee of Adjustment as identified on the agenda and offered no comment.

At the appointed time Mayor Arnold called to order the public meeting called to consider rezoning of property referred to as Part Lot 16, Concession 8, geographic Township of Sombra, Township of St. Clair. Mayor Arnold then called upon Mr. Jeff Baranek with the Lambton County Planning Department who presented his planning merit report on the issue. Mr. Baranek advised that the subject property houses a church and accessory buildings that has been closed. The owners of the property propose, subject to the appropriate rezoning, to sell the property with the existing buildings to be demolished or removed and a single family dwelling developed on the subject site. It was pointed out that the current zoning for the property is Institutional and the proposed new zoning would be Agricultural Non Farm Residential. It was also pointed out by Mr. Baranek that the proposal meets the intent of the Township's Official Plan and in conclusion he supports the adoption of the appropriate rezoning by-law.

Hearing no comments from those in attendance either in opposition or support of the proposal the Mayor declared the public hearing closed.

Mr. McCarthy advised of receiving information from the Ministry of Health requesting that the Township's letter of support be amended to include a provision that St. Clair Township is affiliated with several other Lambton County municipalities to demonstrate the under servicing of the regional area relative to family physicians. Mr. McCarthy pointed out in response to questions from Council that another amendment to the letter could provide that the Township has

affiliated itself with the Sarnia Lambton Health Care Worker Recruitment effort through the Task Force and will not seek separate designation as an under serviced area.

At the conclusion of the discussion Mr. McCarthy advised that the only partner that may be adversely affected by the Township not restating its position would be the Town of Petrolia.

The Clerk advised that the drafting of the bylaw would be completed and Council would have an opportunity to review the terms of the Draft By-law at its next meeting.

COUNCILLORS REPORTS:

Pete Gilliland

Deputy Mayor Gilliland questioned if the Ministry of the Environment have responded to the Township's request made earlier as to the Ministry's findings on the site investigation of the disposal area on the north side of the Courtright Line. Staff was asked to check the status of this response.

Darrell Randell

Councillor Randell advised of a conversation of Mr. Charlie Grant regarding the possibility of naming the road south of the Smith Line referred to locally as the Hay Road. Mr. Grant is requesting the municipality assign a name to the road or provide an explanation why it is

reluctant to do so. Also, Council was advised that the Wilkesport Community Centre is in the process of applying for a Farm Credit Grant, that if accepted would assist in the Hall renovations which include extensive washroom renovations that are planned for 2007. It was pointed out that the results of the grant application would not be known until this fall.

Councillor Randell advised that the Wilkesport Community Centre Board may approach the municipality for a consideration of bridge funding to help finance the project prior to the receipt of grants.

Pat Carswell-Alexander

Councillor Carswell-Alexander asked staff to investigate the relatively long grass at the sanitary sewer pump station in Brigden. Also, staff was asked to provide a status report on the new name pins. Also, advised of receiving a request from Mr. Jack Ford for improved shouldering on the Brigden Road adjacent to his property. Council suggested that this work could be part of the comprehensive rebuilding of that section of the Brigden Road. Also, staff was asked to investigate a drainage problem on the Mike Nantais property at 2346 Courtright Line. In response to staff questions Councillor Carswell-Alexander did not know if the drain in question was, in fact, a municipal drain, an award drain or a private drain.

In response to Councillor Carswell-Alexander's inquiry regarding a small section of private property east of the Pentecostal Church in Corunna. It was suggested to Councillor Carswell-Alexander that the requesting party put their request formally to Council by way of letter.

Council was also advised that several merchants and citizens in Brigden are starting a fund raising campaign to provide for the cost to install Christmas lights in the Village. It was estimated that each light would cost approximately \$400.00 per fixture and the group hopes to finance the purchase of approximately ten fixtures for the 2007 Christmas Season.
