## CLERK'S REPORT:

Council reviewed the report prepared by the Clerk relative to an earlier decision of Council to apply for grant funding under the rural infrastructure investment initiative, in an effort to obtain $75 \%$ funding for a proposed Wilkesport sanitary sewer system. The Clerk's report detailed the implications of the process through the local improvement act to recover the $25 \%$ local cost share if the grant funding request is successful.

## COUNCILLORS REPORTS:

## Pete Gilliland

Deputy Mayor Gilliland questioned staff if any information or timing has been received from the Ministry of the Environment relative to a Ministry inspection of the sludge pond located on Petrolia Line. Council was advised by staff that no information has yet been received from the Ministry. Also, Deputy Mayor Gilliland questioned the status of the Property Standard issue on the Petrolia Line. The Clerk advised that the Property Standards Officer had extended the time frame for compliance to January 24th and that she would re-examine the property after that date.

## Darrell Randell

Councillor Randell advised Council of attending a training opportunity for the Source Water Protection Committee and through the Mayor asked that he be circulated any comments that may be received relative to the LAWS system.

## Pat Carswell-Alexander

Councillor Carswell-Alexander reminded Council of past community involvement in the former landfill site operated by Canadian Waste on LaSalle Road. Staff was asked to contact Canadian Waste for a status report on the facility to include such things as yard and ground maintenance. Councillor Carswell-Alexander also suggested that the St. Clair Township Beacon include Community events hosted within the Township. It was pointed out that there is such provision in the Beacon that the sponsoring group must contact Bonnie Stevensonor the Township office for information to be included in the publication. Councillor Carswell-Alexander also questioned the proposed new telecommunications tower that is subject to a February 6, 2008 site plan committee meeting. The Councillor had questions as to the impact on the health to those living nearby the tower and disrupted television reception. Council suggested that these questions be brought forward by Councillor Carswell-Alexander at the site plan process. The Councillor also asked Council for consideration for possible public open houses to allow public input in the budget process. Councillor Carswell-Alexander is to discuss the concept with Mayor Arnold. The Councillor also asked for a staff report on the public washrooms in Sombra and who is responsible for the maintenance of the facility. Councillor Carswell-Alexander also asked council to consider the possibility of retaining consultants to advise Council on major projects such as the proposed Shell refinery and on issues that may be beyond the expertise of the in house staff. The CAO was asked to draft a report for Committee consideration at its February $13^{\text {th }}$ meeting.

## Pat Brown

Councillor Brown brought to Council's attention the need for road marking on the St. Clair Parkway near the No Frills facility. Councillor Brown also attended with several other Township representatives, the recent Chamber of Commerce breakfast to hear the MP and the MPP speak. While present, Councillor Brown mentioned to MP Pat Davidson, council's position relative to the issue of ice breaking charges being assessed to the Bluewater Ferry in Sombra.

## Steve Arnold

Mayor Arnold advised Council of attending a pre-budget public consultation sponsored by Minister of Finance, Dwight Duncan. Mayor Arnold brought to Minister Duncan's attention several projects such as the proposed Shell refinery, Highway 40 improvements and other projects the Township will bring forward seeking infrastructure funding from the province.

At the appointed time, Mayor Arnold, on behalf of Council, welcomed Mr. Paul Smith present to present to Council his concept plan to develop a heritage district environmental research centre on his property at the intersection of Highway 40 and Oil Springs Line. Mr. Smith pointed out that Shell proposing to buy his fourth generation farm to be incorporated in the buffer zone for the proposed new refinery. Mr. Smith pointed out that his proposal achieves four major goals such as environmental stewardship, environmental research and education, construction worker housing and positive land stewardship. Mr. Smith has pointed out that he has provided his comprehensive plan to Shell and is seeking municipal support to advance the concept. After Mr. Smith's presentation and several questions by Council, it was:

In general terms, Council felt the survey results did not indicate a strong need or demand for a municipally sponsored transit system, but that transit needs may increase in the future.

Motion \#9: That the Township Inter-urban Transit survey be received for information and that no further action be taken at this time to the development of a transit system within the Municipality.

Council discussed the draft agreement between the Municipality and the Sombra Minor Athletic Association to provide interim funding for the washroom upgrade project carried out at the Sombra Park.

Mayor Arnold discussed with Council his ongoing conversation with the officials of the St. Clair Region Conservation Authority relative to the Ministry of the Environment concerns on the Guthrie Park shoreline rehabilitation. Mayor Arnold advised that the Conservation Authority has not as of yet, received cost or proposals from consultants qualified to comment on possible contamination of the shoreline in that area. Council also asked staff to report on the status of the Froomfield sign that was removed last week.
