Mr. Butler stated that when his license was granted last year he had a commercial address in Courtright but due to the fact the property has changed hands he has been required to seek other premises for which to run his taxi cab business. Currently Downriver Taxi is being run out of a rural residence on the Oil Springs Line. Council discussed with Ms. Laird and Mr. Butler in general terms the possibility of redesignated and rezoning the subject property to allow a commercial enterprise in an agricultural area. At the conclusion of the discussion Council directed Staff to prepare a report for Council's consideration at its next meeting on the issue presented by Ms. Laird and Mr. Butler and the implications and ramifications of initiating a planning process to change the Township's Official Plan and Zoning By-law to allow a commercial operation in an agricultural zone. Council pointed out that its next opportunity to consider the Staff report would be at the next meeting of Council which is scheduled for Tuesday, February 19th.

COUNCILLORS REPORTS:

Steve Miller Councillor Miller advised Council that he has attended a recent Port Lambton Community Hall Committee meeting at which time the Committee members discussed possible fund raising activities for the Winter of 2008.

Pat Carswell-Alexander Councillor Carswell-Alexander advised Council of a continuing problem with the heating system at the Brigden Community Hall. It was pointed out that hall improvements have been subject an application for a Trillium Funding with the results of such application as yet unknown. The Councillor felt that if the Trillium grant fundings is unsuccessful provision should be made in the Township's budget for the necessary upgrades. Council requested that Deputy Mayor Gilliland as a member of the Township Trillium Foundation Committee contact the Director of Community Services to get a current comprehensive list on the status of various applications to the Trillium Fund for perhaps possible discussion with the area representatives on the Grant Consideration Committee. Councillor Carswell-Alexander also attended a recent meeting of the Brigden

Library Committee and as well the recent training opportunity sponsored by AMO in London last week. Councillor Carswell-Alexander also made numerous contacts to community groups who may benefit from event announcements in the St. Clair Township Beacon.

Pat Brown Councillor Brown also attended the recent AMO training opportunity last Friday and Saturday at which time part of the discussion involved MPAC in property assessments. It was pointed out at the seminar that properties in Ontario will be reassessed in the 2008 for taxation commencing in the 2009 taxation year with increases if any to be phased over a 4 year period.

Steve Arnold Mayor Arnold advised of attending a recent Shell Open House in Point Edward as well as attending the Sarnia-Lambton Chamber of Commerce awards function and a meeting of the Lambton Farm Safety Association. The Mayor also attended a one day session with the Provincial NDP Environmental critic and the St. Clair Region Conservation Authority Executive Committee meeting. Mayor Arnold also advised of asking the Clerk to contact a representative of Lambton Elderly Outreach who will make a presentation to the next Finance and Administration Committee on services provided particularly in the transportation field by Lambton Elderly Outreach. The Mayor also attended a meeting with Staff and the Consultants who are drafting the plans for the Emergency Services Building in Corunna. It was hoped that the plans could be available for the tender process by the end of February. Council stated its desire to review and approve the final plans prior to tender circulation. Also, the Mayor advised of being invited to attend a tentative meeting on February 12^{th} proposed by neighbours of a proposed dirt track in the Township. The Mayor advised that the organizers hoped to have Municipal Council representative as well as representative from Township Staff who could if called upon could explain the permits and possible planning processes that would be necessary to establish such a track. Staff cautioned Council that such a meeting may be inappropriate for Staff as it may be confused with meetings that may be required if a planning process is applied for. Mayor Arnold also advised of a communication received from Mr. Barry Davis regarding a possible merger of two properties co-owned by Mr. Davis and his sister and Mr. Davis' attempts to create a building lot for his son. Mr. Davis' letter and request for advise and assistance was turned over to Staff for report. The Mayor also advised that the Lambton Farm Safety Association is seeking a municipal grant for 2008 in the amount of \$400.00. Council was reminded of the meeting of the Site Plan Committee to be held Wednesday, February 6th at 7:00 p.m.
