Deputy Mayor Gilliland advised Council that he would be unable to attend the March $9^{\text {th }}$ meeting of the Finance \& Administration Committee and Public Works \& Operations Committee and asked his fellow Councilors to give staff direction on the reconsideration of Council's decision at this meeting relative to the signage for the Township's Emergency Services building in Corunna.

## Darrell Randell

Councillor Randell advised of having the opportunity to accompany St. Clair Region Conservations Authority officials on a fly over of Wallaceburg and the immediate area during the recent flood occurrence. Also Councillor Randell advised of his honor of receiving on behalf of the Friends of the St. Clair River Group, a Conservation Authority award presented at the Authority's annual meeting. Councillor Randell also advised Council that water quality sampling will be reinstituted at the various Township river side parks commencing in 2009. Councillor Randell also advised of information received at the OGRA/ROMA conference about the possibility of securing Building Canada Funding for Brownfield site remediation. Councillor Randell volunteered to make the necessary contacts to pursue this idea.

## Pat Carswell-Alexander

Councillor Carswell-Alexander extended her thanks to Councillor Randell for obtaining the information relative to for funding. Also a resident in Corunna has found copies of the former Corunna news over a one year period, and those editions have been donated to the Moore Museum.

## Pat Brown

Councillor Brown advised of an interesting session held at the OGRA/ROMA conference on alternate energy and green energy sources and as well global warming. Councillor Brown is requesting an updated contact list for senior staff and Councilors.

## Steve Arnold

Mayor Arnold asked staff to investigate the certificate of approval issued by the MOE to Dow Chemical for the apparent land filling activities in St. Clair Township. Mayor Arnold also asked staff to invite Mr. Brian McDougall of the SCRCA to a future Committee of the Whole meeting to provide an overview of the recent flood event in Wallaceburg and surrounding areas. Mayor Arnold briefed Council on the results of the meeting with the Ministry of Finance representatives on the retention of the education levy portion on the gas fired energy plants and as well, the Township's position on the OMPF funding. Mayor Arnold and the delegation were not encouraged by the Minister's response to the education funding issue but sensed some agreement on the OMPF issues. Mayor Arnold also advised Council that he is part of the Chatham-Kent delegation meeting on Wednesday with the Provincial Minister of Health and as well Mayor Arnold has attended several recent meetings relative to the CEE Hospital in Petrolia. The Mayor also requested staff to draft letters of thanks to those responsible for the assistance to the Municipality in securing the Building Canada Infrastructure grant funding for the new Regional Wastewater Treatment Plant. The Mayor also requested a status on the MOE action on the property known as 1784 Petrolia Line. The Mayor also asked for a report on the status on the draft Official Plan Amendment on alternate energy. At the conclusion of his report, the Mayor briefed
