At the appointed time, the Chairman welcomed Mr. Joe Kerr and Mr. Doug McGee present to discuss with Council, their proposal regarding compensation for farm land owners to establish a 6 meter grassed or planted buffer strip adjacent to municipal drains. Mr. Kerr and Mr. McGee stated their opinion that such a buffer strip would reduce future maintenance requirements on those municipal drains and would have a positive effect by reducing erosion that adversely affects the quality of the St. Clair River. Mr. Kerr and Mr. McGee stated that there would be an overall benefit to society for such environmental improvements. The proposal calls for an estimated 570 acres being taken out of active agricultural production required for the establishment of these buffer strips. It is proposed that these farmers would be compensated at the rate of \$100 per year for the loss of productivity of this land per acre with another \$50 per acre paid annually to compensate the farmer for the maintenance of the buffer strip. It was suggested that the method of payment to the farmers would be by way of a property tax credit as opposed to a direct financial compensation. After considerable discussion, Mayor Arnold asked the presenters to provide a more detailed report providing the proposed areas of the Municipality where the program could be implemented. The Mayor

also asked for a more comprehensive report for further consideration by Council and or Committee.
