11. ADJOURNMENT:

Chairperson Carswell-Alexander called the meeting to order at 7:05 p.m. and asked members to declare any conflict of interest at the appropriate time.

DECLARATION OF CONFLICT OF INTEREST:

None declared.

Chairman Carswell-Alexander welcomed Brian McDougall Girish Sankar of the SCRCA and Mr. Milo Strum of ShorePlan Engineering present to discuss with the Committee, a proposal to commence shoreline rehabilitation at Cathcart Park. In his presentation, Mr. Strum advised that based on the engineering study commissioned in 2005, there is approximately 1340 meters of seawall that needs repair or replacement. The Committee was advised that the current steel seawall on the inner channel has an expected life of approximately 5-10 years but based on the pictures provided in Mr. Strum's report the seawall on the outer rim has failed or is failing. Mr. Strum has advised that his group has looked at several possible repair options with the most expensive being replacing the existing wall with a new steel sheet of piling. ShorePlan Engineering is recommending several different types of remediation methods depending on the location within the park. It is projected that based on their recommendation the average cost for the required repairs is approximately \$2000 per meter. It was suggested that the project be broken up into five phases with the first phase to be done on the northwest section of the park. In response to the Committee's questions Mr. Strum advised that this first phase would cost approximately \$350,000 of an estimated total repair cost of \$2.2 million. Mr. McDougall of the SCRCA said that certain grant funds are in place and other funds are being applied for and that if those sources fail with the known funding the Township's contribution to Phase I would be approximately \$100,000. Also in response to the Committee's questions Mr. Strum advised that there are no unusual soil contaminations, the project would have to mitigate. After considerable discussion, it was;
