The Mayor also responded to Councillor DeGurse's questions on County weed mowing equipment.

#### Pat Carswell-Alexander

Councillor Carswell-Alexander led Council in a discussion of the property standards clean up of property known as 2417 Courtright Line in Brigden. Councillor Carswell-Alexander stated that in her opinion and that of the neighbors, considerable amount of derelict equipment including a fuel storage tank and considerable debris and long weeds in the rear yard.

Council reviewed the offer of purchase and sale received from Evelyn Evers for the possible sale by the Township on property adjacent to the Township's Sombra Community Services building referred to as property to the east of the former OPP Station in Sombra. Council was advised that Mr. and Mrs. Evers have confirmed agreement to the Township's conditions for the possible sale of this property including purchase price, legal and survey costs.
