Several neighbors of the Clean Harbors facility were present to discuss with Council the incidents on the weekend in which noxious odors from the Clean harbors facility had an adverse off site impact. Mr. James Stenton asked to address Council to express the group's concerns and question why representatives from the MOE were not present at this meeting of Council. Mayor Arnold advised that the MOE were not invited to attend this meeting but would be invited to attend a future meeting of Council to discuss Clean Harbor's report on off site odor mitigation measures. While present, Mr. Stenton also presented to the Township, several impact statements. Mr. Stenton was critical of Council and what he perceives as its lack of action in addressing the Clean Harbors odor issues and being more diligent in assisting the rate payers' efforts for improvements at the Clean Harbors site. The Mayor stressed that Council is powerless to affect the operations at Clean Harbors and on behalf of Council, expressed its frustration that the odor problem continues. Mr. Stenton as well as several of the others present also expressed their frustration relative to what they consider the lack of effort on behalf of the Township to protect their rights.
