After a brief explanation on the budget process by the Treasurer, Council reviewed the budgets for the Fire Services, Community Services and Public Works respectively. The Committee briefly discussed the need to replace the roof on the Brigden Fire Hall. Chief Dewhirst stated that in his opinion the project at an estimated cost of \$250,000 could be delayed until 2013. The Committee suggests that approximately one half of the estimated costs could be placed in a reserve from the life cycle costing. Also the Committee did not recommend to Council to purchase a new pick up truck for fire services.
