The Court of Revision for the Barnes Drain will hear any appeals that may be made against the assessment as prescribed in the engineers report dated July 5, 2012. Chairman Arnold was advised that one written appeal had been received by Mr. Joe Kerr owner of property known as 806430 ONT. Ltd. Dated Sept 7, 2012. In his appeal Mr. Kerr has cited concerns ranging from grass buffer strips, allowances, and tile outlets. Mr. Kerr was duly sworn. Mr. Kerr presented verbally some of the concerns he had expressed in his appeal dated Sept 7, 2012. At the conclusion of Mr. Kerr's evidence he advised the Court that he has relaxed his position relative to grass buffer strips

Mayor Arnold welcomed Mr.Gord Simmons owner of First Solar and Mr. Joe Gardner local First Solar representative present to discuss with Council the possibility of retro fitting two Municipal buildings with roof top Solar panels. Buildings in question are the Township owned facility at 487 Polymore Dr. and Townships Sports Complex. The Mayor explained to the representatives Councils position relative to its reluctance, for various reasons, including public safety and structural integrity to deny the offer to install such panels on the Moore Sports Complex but may be interested in a proposal relative to the property known as 487 Polymore Dr. Conclusion of the discussion Council suggested that representatives from First Solar could discuss the proposal further with members of senior staff with a report to the next meeting of Council. The Mayor also stated that due to relatively tight time frame Council may be willing to call a special meeting to consider the proposal.

NOW THEREFORE BE IT RESOLVED THAT:

Council of the Township of St. Clair supports without reservation the construction and operation of the Projects in the Township of St. Clair, on buildings and structures referred to as the facility owned by the Township of St. Clair at 487 Polymore Drive, Corunna, a Shell Canada, facility in Corunna, the Corporate Realty Plaza known as the "Foodland Plaza", Corunna and the AF.T. and ANJ building on Polymore Drive, Corunna.

This resolutions sole purpose is to enable the participants in the FIT Program to receive priority points under the FIT Program and may not be used for the purpose of any other form of municipal approval in relation to the Application or Projects or any other purpose.

This resolution shall expire in twelve (12) months after its adoption by council.
