Mr. Burnham discussed with the Committee three possible cost splits between the Municipality and the Province. Consensus of Council was to apply for project funding with 90% of the project cost from the Province and 10% of the project cost from the Municipality. Mayor Arnold advised that he would discuss this potential project with the Deputy Minister of Transportation at a meeting scheduled for December 20, 2013

AON is currently the broker for the Township's Sunlife policy that provides employee benefits and as well is the broker for the Cowan Entities general insurance policies. Sunlife employee benefit insurance has been transferred to Mr. Scott Ewing who as a past employee of AON is familiar with the Townships insurance portfolio both from the employee benefits coverage as well as the Cowan Entities general insurance.
