As well as extending Christmas greeting the Mayor also wished to thank Council and Senior Staff for the support shown over the past two years while he preformed his duties as Lambton County Warden

UNFINISHED BUSINESS:

Council discussed the status of the outstanding Property Standards Order for property known as The Bickford Line. It was pointed out that no efforts have been made to work towards the required clean up of the property. The consensus of Council was that the matter would be further discussed at a future meeting. Council briefly discussed the proposed new Medical Services to be established in Corunna at the newly acquired site at 233 Cameron Street. Council was advised by the Clerk that no approach has been made to the Corunna Medical Clinic physicians for possible short term extension of the blood letting clinic supported by the physicians and the Municipality. It was hoped that the facility would be able to accommodate the blood letting clinic operated by the Rapids Family Health Team by mid to late January 2013.

Council was presented daft resolutions provided by Certified Solar and Solar Powered Network relative to either specific projects in the municipality or a general blanket Municipal endorsement

Moved by J. Agar Seconded by P. Carswell-Alexander <u>Motion #23</u> That Council Support the efforts for the establishment of a solar panel array on property known as 950 Stanley line geographic Township if Sombra Township of St. Clair and 2318190 Ontario Ltd.

DEFEATED

At the appointed time the Mayor called upon MP Pat Davidson to present to Kaitlyn Anderson the Queens Diamond Jubilee Medal in recognition of the charitable work Ms. Anderson has been involved with over the last many years. Mayor commented that Ms. Anderson as a teenager has accomplished more in her charitable efforts than most adults do in a life time.

At 6:00 pm Mayor Arnold called to order the Court of Revisions to hear assessment appeals if any on the Watson Creek Drain. The Clerk advised that an appeal had been received from the County of Lambton relative to the Watson Creek Drain appealing what they considered to be the relative high cost the Bentpath Line crossing incorporated as part of the Watson Creek Drain improvement. County appeal stated that they think the cost of the crossing is excessive due to additional work required due to the proximity of the CSX railway crossing. The Court called upon Mr. Ray Dobbin author of the report to provide an explanation of the assessments as proposed. Mr. Dobbin stated that the road authority would be subject to section 26 of the Drainage Act that states that the work would be tendered separately and the actual cost of the County road crossing will be assessed to the County and it is possible that actual cost maybe less than that estimated by the engineer. Mr. Dobbin also pointed out that an earlier error has been correct at which time additional properties have been moved from a residential category to a agricultural category which would make them eligible for the OMARFA grant. Nicole Lane a rate payer residing at 124 Smith Street was present to present a verbal appeal to the court.

Moved by D. Randell Seconded by P. Gilliland Motion #25 That the Court of Revision hear verbal appeals offered from the audience.

Ms. Lane stated that she was under impression that an early proposal was to see her property levied approximately \$700.00 and the current final proposed assessment is approximately \$6200.00 Mr. Dobbin stated that \$1150.00 has been estimated as a special benefit with an outlet assessment of \$450.00 with a benefit assessment of approximately \$4596.00 Ms Lane stated that her house is on a lot cornering on Smith street and Duke Street and that some of her drainage water flows south into a drain on Smith Street and in fact there are two drain outlets provided for her property into the new drain on Duke Street to be incorporated as part of the Watson Creek drain that she does not feel that she requires. Mr. Dobbin thought that at least one connection should be installed but that perhaps a assessment reduction could be made if only one outlet is constructed. The Clerk cautioned that the assessment method suggested by Mr. Dobbin would be difficult if not impossible to calculate.

Agar Motion #26 That the assessment for the property known as 124 Smith Street owned by Nicole Lane be reduced by \$3000.00 and that the additional \$3000.00 be included as an additional levy to the Smith St. road allowance and further that the earlier amendments by the engineer to incorporate additional property as agricultural that are eligible for the OMAFRA grant be accepted and that the Court of Revision on the Watson Creek Drain be closed.
