Mr. Hackett also advised of the need to relocate or dispose of records from the former Township of Sombra that are stored in the attic space of the building. The Committee suggested that the records and files be transferred to the Sombra Museum for safe keeping to enable the Clerk to initially review the records to determine and to retrieve anything of historical significance. The Committee also discussed Mr. Hackett's report on the apparent failure of the south rink due perhaps to a pervious ammonia leak and the need to have the source of the problem identified and a costing obtained.

Mr. DePooter introduced the new Drainage Technician Mr. Jordan Gray to members of the Committee and staff. The Committee members welcomed Mr. Gray and wished him every success in his future with St. Clair Township.

DIRECTOR OF PUBLIC WORKS REPORT:

The Committee discussed with Mr. Deline Mr. Burnham's report regarding the investigation of possible odour reduction strategies at the new Regional Waste Water Treatment Plant.

Mr. Deline stated the opinion of Mr. Burnham that as operators of the system CH2M HILL maybe better qualified to investigate odour reduction strategies and opportunities at the plant than AECOM, who were the original designers of the system, particularly in lieu of the retirement of Mr. Don Kemp. Several members of the Committee thought that any odour reduction strategy should be investigated during warmer weather which was perhaps the basis of complaints received in the operation of the plant last summer and fall.
