Mayor Arnold stated that he would be in Toronto on May 21 meeting with representatives from Ontario Power Generation and he would thereby miss County Council.

- 1) Landlocked Parcel The Clerk reminded council of a land locked parcel west of Nash Court in Corunna and a report that was before council at their first meeting April 29, 2014. At that time staff was directed to research how much tax was paid on the property and Clerk informed Council the taxes collected in 2013 were \$80.40. No further direction was provided.
- 2) Vendor Permit 159 King Street At the last meeting of Council Brenda Coulombe requested a vendor's permit for 159 King Street and was told to produce authorization from the Ministry of Health, and the Fire Department. The Clerk informed Council that the Ministry of Health provided documentation indicating no cooking could be done within the unit as there is no CO2 unit. Since no interior cooking was permitted there was no permit required from the fire department.

Mayor Arnold declared a conflict of interest with the Vandertil & Broad Drain and vacated his chair for both court hearings leaving Deputy Mayor Gilliland as Chairperson for the proceedings. Deputy Mayor Gilliland called to order the Court of Revision to hear any assessment appeals on the Vandertil & Broad Drain, and the Powers Drain West. In discussion of the Powers Drain West assessment the Clerk advised that no written appeals had been received. No verbal appeals were offered at this sitting of the Court.

Engineer Ray Dobbin summarized his report and informed the Court that he had no correspondence with anyone associated with the drain since the consideration meeting.

Motion #18 That the Engineer's assessment on the Powers Drain West in accordance with the Engineer's report dated January 31, 2014 be accepted and confirmed and that the Court of Revision on the Powers Drain West be closed.

7:05 - Vandertil & Broad Drain

Engineer Ray Dobbin summarized his report and informed the Court that he had no correspondence with anyone associated with the drain since the consideration meeting. He further stated that there is a parcel of land with roll number 50-063 with an assessment of \$2807 that is actually not in the watershed for the Vandertil and Broad Drain. It was his recommendation that 2/3 of this assessment be absorbed by E & R Vandertil, and the remaining 1/3 be assessed to Union Gas.

Carswell-Alexander Motion #19 That the Engineer's report on the Vandertil and Broad Drain dated March 15, 2014 be accepted and confirmed including removing the assessment for 50-063 and putting 2/3 of that assessment onto 50-062 and the remaining 1/3 onto 50-044 and that the Court of Revision on the Vandertil and Broad Drain be adjourned.
