DEPUTATIONS:

Royal Canadian Legion:

At the appointed time of 6:45 p.m., Mayor Arnold asked Louise Ogilvie, President of Royal Canadian Legion Branch 635, to come forward.

Louise presented the Mayor and Council an award to recognize their continued contributions to Branch 635, further thanking them for the new flagpole and sidewalk recently installed at the Brigden cenotaph.

Mayor Arnold graciously accepted the award and thanked Louise for all the hard work put forth by Branch 635 in the community.

Jim and Stephanie Degurse:

Mayor Arnold then took the opportunity to present a certificate of achievement and congratulate Councillor Jim Degurse and his wife Stephanie on their 50th wedding anniversary. Congratulations!

Paul DeMars – Fence Variance – 4664 Riverside Drive:

At the appointed time of 7:00 p.m., Mayor Arnold asked Paul DeMars to come forward and explain the variance request to Council.

Paul DeMars advised Council that he is only seeking to erect a fence along his southern property line and would like to use wood, although he would use chain link. He submitted photographs to Council showing that vision is not an issue here as there is already a boat house prohibiting a view of the water.

Clerk Jeff Baranek advised Council of six letters of opposition received from neighbours and read letters from the following people: John and Susan Colley of 4674 Riverside Drive, Darryl Gray of 4668 Riverside Drive, Mary McFadden of 4667 Riverside Drive, John Bowman of 4659 Riverside Drive, Bob Murphy, and Richard and Karen McCready of 4661 Crescent Drive.

Deputy Mayor Peter Gilliland sought clarification as to why the fence was necessary and Mr. DeMars informed Council that he wished to grow pumpkins and that he had grandkids. Councillor Miller asked if the fence was intended to close in the canal waterway, and Mr. DeMars indicated that it was not, and would only be erected along the south property line.

Councillor Miller advised that he visited the site and there are other fences in the area, but they pre-date the by-law which was put in place by Council to retain control of fences in the area in an effort to maintain the integrity of the area and preserve views.

Mr. Gray advised Council that, as per his letter, he is concerned with the location of the fence as his seawall tie-backs cross the property line and he is worried about them being damaged during fence post installation, as well as with future maintenance. Further, Mr. Gray is concerned the location of the fence may impact the location of his air conditioner as a survey shows the concrete pad it sits on is dissected by the lot line.

Eric Allaer – Geese in Brander Park:

At the appointed time of 7:15p.m., Mayor Arnold called Eric Allaer to come forward to make his presentation to Council.

Mr. Allaer advised Council that he lives across from Brander Park and that the geese infestation makes the enjoyment of the park impossible. He cited many health concerns that fecal matter from geese presents and indicated they have made using the trail within the park disgusting at times. He commended Council on their recent investment in the park and acknowledged it is a very nice asset within the Township.

Among ways to assist with this issue, Mr. Allaer cited hunting, control of eggs, bird bangers and other methods to scare them off.

Mayor Arnold advised Mr. Allaer that we had an issue in some other parks and at the golf course and that our Director of Community Services Gary Hackett has had some success removing them. He informed Mr. Allaer that Gary will get in contact with him and that he will draft a report identifying some possible options to reduce the geese population within the park and estimated costs.

Marietta Zammitt – Alley Maintenance:

At the appointed time of 7:25 p.m., Mayor Arnold called Marietta Zammitt to come forward to make her presentation to Council.

Marietta advised Council that she resides at 1195 Emily Street and has an alley between her property and the neighbour behind her. The neighbour behind her has taken the alley and planted shrubbery and a garden which is now leaning over and through her fence. This fence was replaced in 2012 and this shrubbery has caused it to already be in disrepair. She advised Council that she approached the landowner to remove the vegetation and the confrontation became contentious resulting in no progress. She is asking Council to maintain and remove the vegetation from the alley.

COUNCILLOR'S REPORTS:

Peter Gilliland:

Deputy Mayor Gilliland advised Council of a loose plank in the rail crossing at Moore Line near Nova and asked staff to look into its repair.

Jeff Agar:

Councillor Agar advised Council that he brought greetings on their behalf to the Elderly Outreach dinner. He continued by reflecting Mayor Arnold's previous congratulations to Jim and Stephanie Degurse on their 50th wedding anniversary. He concluded by highlighting the ineffectiveness of the crosswalk at Beckwith and St. Clair Parkway as he witnessed a lady use the crosswalk safely, but then 5 cars didn't even slow down when the lights were flashing as they raced through. The OPP should be made aware of this and Councillor Miller can bring this up at the next police board meeting.

Steve Miller:

Councillor Miller advised Council that the representatives from Rogers didn't show up to the public meeting related to a telecommunications tower proposed for the works yard on Moore Line. He then reminded Council of a retirement open house for Les Fournie on Thursday May 7 at 4-6 p.m.

Tracy Kingston:

Councillor Kingston advised Council of the upcoming Youth Appreciation Night hosted by the Moore Optimists. She continued by expressing her concern about the parking lane in downtown Corunna being used as a passing lane and the dangers it presents. She concluded by advising that she, along with Shirley Warner and Harry Rome, attended a property standards appeal committee training session. Among the things she learned was that Council should not be dealing with extensions to Orders, as that is the responsibility of the Appeal Committee.

Jim Degurse:

Councillor Degurse advised Council that the Shred It day held on May 3 in Corunna was a success as they had 185 people take the opportunity to have documents shredded.

Mayor Steve Arnold:

Mayor Arnold advised Council that he attended the OSUM (Ontario Small Urban Municipalities) conference in Belleville last week where he was introduced to many innovative concepts including accessible park benches and tables, and a mountable radar gun that records speed of passing vehicles.

Among the highlights of the conference, Mayor Arnold was able to achieve a private audience with Premier Wynne where he discussed the closure of the OPG plant. She admitted its closure was an unfortunate unforeseen result of the Green Energy Act and she provided the name of someone within her office for the Mayor to contact to set up a subsequent meeting related to the OPG site and its future.
