Court of Revision:

Hescott-Anderson Drain

At the appointed time of 6:45 p.m., Mayor Arnold called the Court of Revision to Order to consider appeals on the Hescott-Anderson Drain. Mayor Arnold welcomed Ray Dobbin, the engineer for the report dated June 4, 2015, to present any changes to the assessment schedules.

Mr. Dobbin advised that comments submitted by Gerald MacPherson influenced some changes in watershed and ultimately led to an increase in assessment for three properties: Township Public Works Yard (\$201), Parkway Golf Course (\$82) and a property owned by Suncor (\$1650).

Correspondingly, four properties had their assessment value decreased by the amended watershed: Township Moore Road (\$59), G. Rosso property (\$133), L & N Park property (\$63) and R&L MacPherson (\$70).

Mayor Arnold asked anyone in attendance if they wished to speak to their assessments and nobody came forward.

Mr. Dobbin advised Council that, since three properties had increased assessments with the revisions to the report, the Court must re-convene to allow the owners an avenue to appeal the new value.

He continues by advising the barrier free parking space at the Corunna Post Office is continually occupied by vehicles without a permit and was advised by the Clerk that this is enforced by the OPP. He then questioned our parking tickets fines and how they compared to that of other municipalities.

Mayor Arnold:

Mayor Arnold represented the Township at many events since the last meeting of Council including the 80th Birthday party for Councillor Randell's mother Grace Dunseith which was a wonderful time. He had a meeting with the new GM for CF Industries and identified some upcoming projects within the Township that are seeking sponsorship donations. He attended the Brigden Fire Ladies/Spouses Night where Jim Brown was honoured by past and present firefighters upon his retirement after 35 years of service.

At the OGRA/ROMA Conference he represented the Township in a delegation with the Ministry of Energy where the state of Lambton Generating Station was discussed, and continued discussions were had with MPAC around concerns with the continued depleting assessment for the site.

Mayor Arnold concluded by advising he was exploring a budget with Geoff Dale for a celebration to unveil the St. George Square monument to commemorate Canada's Sesquicentennial - 150th Birthday. This celebration will include fireworks and many activities for the kids – similar to the setup up of the Captain Kidd's summer festival, operated by Mr. Dale.
