Special Olympic Flag Relay

At the appointed time of 6:35 p.m., Mayor Arnold welcomed Michael Hendrycks to come forward with the 2017 Special Olympic Flag. The Knights of Columbus remain the major sponsor for Special Olympics which will be held in Hamilton in 2017. This is one of 13 flags which will be sent across the country for signatures before becoming part of the Games in Hamilton. The Knights of Columbus will have raised over \$4 million by the time the Games are opened this summer. There are three local athletes competing in this year's games.

Mayor Arnold commended the efforts of the Knights of Columbus, not only for their continued support of the Special Olympics but, for all the programs spearheaded by the K of C within the Township.

BIOX – Forge Project

At the appointed time of 6:45 p.m., Mayor Arnold welcomed Nak Paik and Tim Haig of BIOX – Forge.

Currently in Hamilton, a BIOX facility has been constructed with a capacity to produce 70,000,000 litres of biodiesel. The forthcoming FORGE technology was purchased from the University of Alberta and will have the capacity to produce 25,000,000 litres of Renewable Diesel Fuel which produces 90% less greenhouse gas than petroleum. This product does not contain a catalyst that many other biodiesel products do making it a preferred "drop in fuel" in the hydrocarbon industry.

The fuel at the Sombra plant will be produced off-site and assembled on-site. Local tradesmen will be used for as much of the development as possible. The system is a closed system limiting any off-site impact to minimal. Odours will not be observed off of the property while in operation. The original plan would see an average of 10 trucks coming and leaving the site daily but, focus will shift to rail once in operation. In total, the local investment to the community will be excess of \$25 million. A heavy emphasis will be placed on being a "good member of the community."

Mayor Arnold thanked them for the presentation and welcomed them to the Township.

St. Clair River Trail

At the appointed time of 7:00 p.m., Mayor Arnold welcomed Jane Marsh and Dave Cram of the St. Clair River Trail Committee.

As the Trail is now completed, the Committee will switch their focus to maintenance and improvements. Sections of the Trail are now 19 years old and are in need of some attention. The Committee is looking to establish responsibilities for the continued maintenance of the Trail and hopes to continue their partnership with the Township.

The SCRT Committee intends to continue meeting regularly and are currently undertaking a bench replacement program to replace all wooden benches presently along the trail with locally built aluminum units. The Committee continues to have eager volunteers offer to maintain the Trail but, liability concerns limit the scope of a volunteer's role.

A Chart of Responsibilities has been drafted by the Committee and Township staff identifying roles of both the Committee and the Township moving forward. The Committee has asked Council to review the document and report back with any amendments or comments.

Mayor Arnold advised that a fundraising agreement will remain in place to offset costs for future projects and maintenance. He also thanked the SCRT Committee for their tireless efforts in the design and construction of the Trail. It is a landmark within the community. Council looks forward to a continued partnership in improving and maintaining the St. Clair River Trail.
