Heritage St. Clair (HSC) continues to work on several projects including the hamlet project which involves the of replacement and installation of additional story boards and maintenance of abandoned cemeteries. International boundary markers at Stag Island are very close to being produced along with the production of bronze plaques. The board has also recently welcomed a few new members to the Committee.

Mrs. Kingston outlines the Committee's 2025 budget request for various proposed projects which is planned to be submitted to the Township's Treasurer for Council's consideration as part of the 2025 Annual Budget.
