Describe your Drinking-Water System

The Corporation of the Township of St. Clair operates the St. Clair Township Water Distribution System which consists of the Brigden Elevated Water Tower and the distribution water mains of the Township of St. Clair. The St. Clair Township Water Distribution System receives its water directly from the Lambton Area Water Supply System (LAWSS). The LAWSS water treatment plant is located at the junction of Lake Huron and the St. Clair River in the City of Sarnia. Prior to distribution, the Lambton WTP adds chlorine and fluoride to the finished water. The water is re-chlorinated at West Lambton Pumping Station prior to entering the Township. The water is re-chlorinated at the Brigden Elevated Water Tower for maintaining the free chlorine residual in the St. Clair distribution system. The water distribution system chlorine residual is monitored continuously in Port Lambton.
