

THE CORPORATION OF THE TOWNSHIP OF ST. CLAIR

BYLAW 61 OF 2024

Being a by-law to establish Standing Committees of Council and to establish certain appointments for the Township of St. Clair for two year appointments through December 31, 2026

WHEREAS the Municipal Council of The Township of St. Clair deems it expedient to create standing Committees of Council to assist it in providing efficient and responsive local government and to appoint citizens as its representatives to various external Boards, Commissions and bodies:

NOW THEREFORE the following provisions be enacted:

- 1. That the following Standing Committees of Council, as per Schedule 'A' to this by-law be established with the mandate to deal with the pertinent issues as their names denote or other issues that may be referred by Council or other Committees from time to time for study and recommendation and further that appointments to various external boards, commissions and bodies, and offices be established and confirmed, including rates of compensation;
- 2. That members of these committees and representatives shall be compensated at a rate of remuneration as established by Council.
- 3. That the Mayor shall be an ex-officio member of all Committees established by Council.
- 4. That Council may amend or alter these appointments by resolution or by-law as and when desired.
- 5. That the appointments identified in Schedule 'A' to this Bylaw be valid for two years beginning in 2025 and terminating December 31, 2026.
- 6. That any by-law conflicting with this by-law hereby be repealed;
- 7. That this by-law shall be in force as of the date of passing and shall remain in force until amended or repealed;
- 8. That By-law 64 of 2022 be hereby repealed.

READ a FIRST, SECOND, and THIRD and FINAL time this 16th day of December 2024.
