

Palm Sunday visitor delights Corunna church congregation

This year's Palm Sunday service at St. Joseph's Catholic Church in Corunna featured a very special guest. Poncho, the miniature donkey, was on hand to help Father Jan Pochwala illustrate the Easter story, specifically, the entry of Jesus into Jerusalem on the back of a donkey. Little Poncho accompanied Father Jan in the procession from the parish hall to the church and right up to the altar. Poncho is owned by Paul and Jan Smith of Oil Springs Line in St. Clair Township.

One of the features that sets Poncho's breed apart from other breeds is the naturally-occurring cross that marks his back. This cross has found its own place in Easter lore. It is said that, when Jesus was condemned to be crucified, the little donkey he'd been riding wanted to



help him carry the cross. When he was pushed away by Roman soldiers, he remained at the scene of the crucifixion until everyone had left. As he turned to leave, the shadow of the cross fell upon his back and remained there as a tribute to his loyalty.

Fire chief stresses importance of smoke alarms

The importance of smoke alarms was vividly demonstrated recently when five people, including three young children, died in a house fire in Hamilton, Ontario. It has been confirmed by the Office of the Fire Marshal investigators that there were no working smoke alarms in the victims' home.

"How many more fire deaths have to needlessly occur before people get the message," said Roy Dewhirst, Fire Chief of St. Clair Township. "This young family would probably still be alive today if there had been working smoke alarms in their home."

So far this year, 32 people have died in fires across Ontario, and many of these have been children. Some of these investigations are still ongoing, but the

St. Clair Township Fire Department is urging everyone to test their smoke alarms.

In order to survive a fire, you need to be provided with an early warning and know what to do when the smoke alarm sounds. In Ontario, the law states that a working smoke alarm must be located on every storey of a residence and outside all sleeping areas. For added protection, it is recommended that smoke alarms be installed inside all bedrooms.

"Smoke alarms can give you and your family the precious time needed to get out safely," said Deputy Fire Chief Tom Boon. "A few minutes spent testing your smoke alarms and practicing a home fire

Trail completion and funding discussed

Trail funding discussed

St. Clair River Trail cochairs Jane Marsh and Peter Cassel attended the March 17 meeting of council to ask that proposed funding changes regarding the trail be reconsidered.

The change would have seen the current funding match ratio of 2:1 with a cap of \$100,000 reduced to a funding match ratio of 1:1 with a cap of \$50,000. Jane Marsh noted that the change would drastically affect the work of the volunteer committee and its goal of completing the trail's unfinished portions, about seven to eight kilometres in length. The estimated cost of completion is \$750,000, not counting the link to Kent County.

She said 2008 will be a rebuilding and planning year in order to begin construction of the 1.92 kilometre trail section from Sombra to Hold Line at an estimated cost of \$211,000. Marsh added this will happen when sufficient funds have been raised since, at the end of 2007, the committee had no funds left for trail construction.

Marsh says the committee is concern that if the current funding policy is changed, it will take about twice as long to complete the rest of the trail.

A motion was made to amend the proposed change so that a 2:1 ratio would apply to money made through committee fundraising and a 1:1 ratio would apply to funds garnered through grants to a limit of \$100,000.

In passing this motion, council noted that the efforts of the trail committee are appreciated and that the trail is a valuable resource for the residents of St. Clair Township.

Off-leash dog park proposed

Resident Maria Beauchamp attended the March 17 meeting of council to suggest the creation of an off-leash dog park in the Corunna area. She told council that in speaking with residents adjacent to Duggan Field, she has received 100 per cent favourable response to the idea.

Mayor Steve Arnold asked that a signed petition be tendered, indicating residents in favour of such a park. Beauchamp responded that such a petition exists and that she will continue to circulate it.

Some concern was raised as to who would be responsible for keeping the park clean. It was noted that some dog owners are irresponsible when it comes to cleaning up after their pet and the park's upkeep could result in some cost to the municipality.

In the meantime, it was pointed out that there has been a request to restore Duggan Field to its former use as a baseball diamond, even though it has not been used for this purpose in recent years. The matter will be turned over to the municipal parks board and will also be discussed with the municipality's insurance underwriters.

Sewer extension set

A court of revision was held to discuss the sanitary sewer extension along the St. Clair Parkway south of Courtright. About three residents were on hand for the proceedings. Clerk John DeMars noted that no written appeals had been received concerning the individual property assessments. He added that assessments could only be challenged due to "gross and manifest errors."

In response to a question from one of the residents, Clerk DeMars stated that the initial down payment on the assessment can vary, but the balance must be repaid over a 10-year period to comply with provincial financing requirements.

Report on proposed dirt bike track reviewed

In response to concerns expressed to council over the construction of a dirt bike track near Corunna, council reviewed the clerk's report. The report states that the municipality's existing noise by-law may have an effect if the track proves a disturbance to adjacent neighbours. Council voted to receive the report for information purposes.

Sportsman's club to host regional event

Ed Allin of the Lambton Sportsman Club went before council on March 3 to request financial support to help sponsor the 2008 Cowboy Action Shoot set for July 12 and 13. This event is part of the Southwestern Ontario Regional Shoot. Mr. Allin explained that this competition will attract participants from as far away as New York and Quebec, as well as Michigan and Ontario. The club expects there will be over 125 participants at the event, which will be held at the club's facility on Bickford Line. The club requires funds to help pay for the cost of renting a tent, seating for 200 and portable washrooms to accommodate those who attend. Council approved a grant of \$500 and waived the building permit fee for the tents.

Splash pad for Sombra Park

The council chamber was filled to capacity when Sombra residents and their children visited on March 3. The group appeared in support of a new splash pad project proposed for Sombra Park.

Todd Sharpless, spokesman for the Sombra Sports and Recreation Committee Todd Sharpless outlined the community's involvement and support for the new splash pad, and made a pres-

entation as to the scope of the project. He advised that the proposed equipment is computer-controlled and timed, and would occupy a surface area of approximately 117 square metres. He also reviewed the committee's past accomplishments and noted that these accomplishments had been facilitated through successful fundraising activities.

The current project calls for the construction of the splash pad at a cost of about \$109,000 with a requested contribution from the municipality of \$54,600. Also, the proposal contained a repayment schedule. The repayment of the requested loan from the municipality would run from 2008 to 2012 inclusive.

The splash pad is seen as a desirable alternative to a wading pool, since it does not require the addition of strong chemicals and will not promote bacterial growth. This is important, since some of the children who will be using the facility are medically fragile.

Council accepted the proposal set forward by the committee. The township will provide an initial loan and an estimated grant of \$54,645 for the establishment of a splash pad. This will be financed through the municipality's Education and Environment Fund.

Council also commended the committee and Sombra residents for their ability to further improvements in their community through enthusiastic fundraising activities.

escape plan could make the difference between life and death."

It is recommended that batteries in all smoke alarms should be changed at least once per year. Boon says the easy way to remember this is to do it at the same time each year, for instance, when you turn the clocks forward or back. It is also necessary to keep these alarms clear of cobwebs, dust and other debris that might interfere with the delicate sensors. This can be done very

easily by vacuuming the case. And since smoke alarms have a finite lifespan, it is also necessary to change them after about 10 years. Be sure to consult the manufacturer's instructions that accompany each alarm to be sure it is installed and set up properly.

Tampering with or removing the batteries from a smoke alarm is also against the law. Failure to comply with the Fire Code smoke alarm requirements can result in a ticket of \$235 or a fine of up to \$50,000 and/ or a year in jail.

COUNCIL DIARY

Projects benefit residents and environment

Councillor Darrell Randell is the author of this month's council column. Watch for this column each month for insights directly from your municipal council.

The most pleasant thing about being on council is seeing projects completed that are very much needed. There is satisfaction in seeing the development of recreational projects like the St. Clair River Trail or the splash pad about to be constructed at the Sombra Park. These are softer service-type things that involve very dedicated volunteers making a difference in their community. They're great projects and are a justifiable source of pride for many.

And I find even greater satisfaction in the harder service projects. The quality of water in the St. Clair River is improved because of sanitary sewer extension projects like the one most recently completed for the Frog Point residents. The only built-up areas in the township still not currently serviced are Froomfield and Wilkesport. Plans are in the works to rectify this situation and it will be a happy day when all the work has been completed.

Having our residents' homes safe from flooding because of street reconstruction projects that include larger storm water drains is a great relief for both council and homeowners. Destructive things like residential flooding should not happen.

Thinking back a few years, the extension of potable water lines into the rural areas must have been greatly needed because we never anticipated it would be achieved as quickly as it was. There are, of course, still waterline projects to be completed, but these are mainly to loop and back up the system and maintain pressure.

Projects do not always proceed in a straightforward way. Our plans to fix the shoreline in Guthrie Park have hit a large snag. We knew the adjacent river bottom contained contaminated sediments, but tests have shown contaminant levels are still very high. Our plans are currently under revision, but our MP, Pat Davidson, has announced \$3.3 million of Environment Canada funds to address this issue in the St. Clair River. This is not the only area needing work, but the township will cooperate with numerous government agencies to remediate it.

What I take the greatest pride in are the projects we do that can provide security and peace of mind, and make St. Clair Township more sustainable and liveable.

*Corrosive materials, including batteries, drain cleaners and oven cleaners.

*Toxic materials, including pesticides, rat poison, pharmaceuticals and cleaning fluids.

*Reactive materials, including pool chemicals, ammonia, bleach and aerosols.

*Flammable materials, including gasoline, paint, barbeque starter, oils, solvents and propane cylinders.

*Sharps (hypodermic needles).

The following materials <u>will not</u> be accepted: PCBs, commercially-generated, infectious or radioactive wastes, and tires.
