# Family Day is Monday, February 16

Family Day is a provincial holiday that is also celebrated in Albert and Saskatchewan. It is intended to give families the opportunity to spend some quality time together. Family Day gives Ontario employees who are covered by the Employment Standards Act, 2000 and their families a total of nine public holidays per year.

# Residents reminded seasonal parking restrictions in effect

The cooperation of the public is being sought to ensure that public roads can be plowed efficiently. It is illegal to park on public roads and streets from 2 a.m. to 6 a.m. Leaving the roadways clear of vehicles allows snow plow crews to do their jobs effectively. Those who do not comply with this winter parking restriction will be fined and St. Clair Township Clerk John DeMars says a parking blitz is currently underway. Tickets are being issued to motorists who do not comply with this restriction in the hope that this will help keep the roads clear of snow. Every vehicle owner is responsible for keeping their vehicles off public roads.

Also, property owners are urged not to push snow out onto public roadways when clearing driveways and walkways. This creates a hazard to oncoming traffic and is an offence under the Highway Traffic Act.

# Municipal dog tags available

Residents of St. Clair Township are reminded that it's time to purchase the annual dog license. All dogs are required to have a current licence, which provides identification for the animal should it become lost. These licences are available at the St. Clair Township Civic Centre, 1155 Emily Street. The price of a tag

is as follows: \$15 for female spayed with rabies shot; \$15 for male neutered with rabies shot; \$25 for female spayed with no rabies shot; \$25 for male neutered with no rabies shot; \$35 for male unneutered with rabies shot; \$75 for kennel licence. # Coyote concerns unfounded says dog catcher

The presence of coyotes in St. Clair Township, some sighted close to populated areas, has raised concern in many residents and the mysterious disappearance of some domestic cats has been attributed to these animals.

But municipal dog catcher Gayle Farr says there is little to fear from coyotes. "These are shy animals," she said. "They keep to themselves."

Farr suggests that the real culprits responsible for the vanishing felines are probably winged ones.

"Coyotes are not the problem. These are owls," she said, noting these birds of prey can grow to about three feet in height. "We're 100 per cent positive that horned owls were taking the cats. They're silent and they come at night."

# Renewable energy policies discussed

A recent public meeting was held to consider Official Plan Amendment #12 and a rezoning bylaw to establish policies relative to renewable energy facilities in St. Clair Township. Lambton County planner Barry Uitvlugt presented his report. He pointed out that the draft documents provided for regulations relative to wind generation power, solar-generated power and biomass-generated power.

Councillor Carswell-Alexander asked if the issue of stray voltage was part of the research done to produce the draft documents. Mayor Arnold advised it was his understanding that stray voltage could be reduced considerably if the transmission lines are buried to a sufficient depth. However, he expressed several concerns. One was that Class 1 farmlands could be lost to solar energy development. Another was that perhaps lands could still be used for pasturing and grazing if, in such a development, the panel height could be adjusted to allow it.

Mayor Arnold also stated that he hoped the community would receive an economic benefit from these renewable energy sources. Mr. Uitvlugt advised that the proposal for two per cent cash in lieu was based on the value of the host land prior to its development.

Tom Lewis of IPC Energy noted the current draft documents seem to meet provincial renewable energy policy but the site provisions may limit or even prohibit the establishment of wind turbines. Mr. Lewis stated that, in his opinion, St. Clair Township does not welcome wind turbine facilities, to which Mayor Arnold responded that every attempt is being made to protect the natural environment and areas of

significance such as the St. Clair River, the township's forested areas and the petrochemical facilities. He said alternative energy facilities should compliment these features, not detract from them.

Township resident Tom Wilson advised that his concerns were similar to council's, citing health problems that have developed in some neighbours of wind turbine facilities in Ripley, Ontario. Mr. Wilson also expressed concern over who would be responsible for mechanical failure of a wind turbine facility if it caused damage to a neighbour's property. He also shared the Mayor's concern about security for future decommissioning of the facility.

As a result of the meeting, a motion of council regarding the report submitted by Mr. Uitvlugt was carried, and the report was received and accepted. The draft Official Plan and Zoning By-law Amendments will take into consideration the discussions and is-

sues raised at the public meeting.


# Council meeting schedule

# Township coping with economic downturn

This month's Council Diary is written by Mayor Steve Arnold. For insights directly from the council chambers, watch for this column each month in The Beacon.

I hope this column finds everyone in a good spot and that the current economic times we are facing have not impacted you in a negative way. Personally, I have been struggling a bit over the past few weeks. It's something we all can relate to from time to time in our lives, but like the rest of you, I am a survivor and everything will work out fine

I've had the opportunity to travel through our great township on many occasions and I often see our youth, their enthusiasm, their drive, their determination, their willingness to stand up for a cause and see it through - it gives me great hope for our future.

I have also spent some time over the past couple of weeks with people who are considering starting businesses here. One of the reasons they give for this decision involves the positive atmosphere of our community. Everywhere they go, it seems they are met with a smile, a warm comment (much needed this winter,) and they speak to me about the main fabric of our community being the volunteers in so many organizations that they have encountered. It gives them a feeling of belonging and a hope that the

future in St. Clair Township will be bright.

On Council, we have tentatively set our capital budget and our engineering folks are working through the big projects. We also continue to lobby on a regular basis with senior levels of government to garner additional funds for these projects prior to implementation. In the next few weeks, we will be starting the operating budget. Our goal is to maintain the dollar value of our taxes at the current level no matter what the changes in the assessments for a number of individuals and corporations might be. That in itself will be a challenge, however, we need to make sure there is an aspect of our taxes that is stabilized. As most of you know though, out of every dollar of taxes raised locally, 23 per cent is township, 27 per cent is county and the balance, 50 per cent, comprises the education component. As you can see, everything we do in this township - plowing the snow, collecting garbage, fighting fires, repairing roads, and operating our museums, libraries, arenas, parks, minor sports, and our community centers, is funded by a small portion of the total tax bill.

Keep warm this winter and remember that some of the people you meet may be considering opening a business here, providing jobs for those in our community, so keep smilin'.
