**WHEREAS** on December 17, 2009, Bill 212, Sched. 21, s.8 (44), Municipal Elections Act, 1996 (MEA) reform was proclaimed, effective January 1, 2010;

**WHEREAS** Section 81.1 of the Municipal Elections Act, 1996, as amended, requires that Councils appoint a Joint Compliance Audit Committee for the purposes of Section 81, 2009, c.33, Sched. 21, s.8 (44);

**WHEREAS** municipalities may establish a Joint Compliance Audit Committee;


**WHEREAS** the Councils of the Townships of Brooke-Alvinston, Dawn-Euphemia, Enniskillen, St. Clair and Warwick, the Municipality of Lambton Shores, the Town of Plympton-Wyoming and the Village of Point Edward deem it advisable and expedient to establish a Joint Compliance Audit Committee;




